## **Data Governance Council (DGC)**

## **Purpose**

The purpose of the Data Governance Council (DGC) is to establish the mechanisms for developing and managing New York Tech's data resources. These include data, metrics derived from data, data-delivery platforms and tools, and the many University relationships and processes that support these resources. The DGC will address strategic issues within these broad domains:

- Policies, Procedures and Standards. Facilitating the development of policies, procedures and standards to ensure that data
  are created, managed, accessed and used in an effective and ethical manner.
- **Data Quality and Consistency.** Creating the mechanisms and supporting documentation to ensure that data are accurate and uniform across departments, schools and colleges and over time.
- Privacy, Security, Compliance and Risk Management. Working with ITS, the Information Security and Privacy Council, and
  other operational security and risk management groups to develop risk management and compliance strategies to ensure
  data remains protected and available as a strategic asset for the University.
- Architecture, Integration and Storage. Creating clear and commonly-used structures, models, definitions, and processes
  across multiple platforms to support coordination and collaboration, effective decision-support, and efficient operations.
- **Communication, Collaboration and Training.** Promoting regular and open dialogue amongst member of the New York Tech community about the importance of good data stewardship practices.

DGC will engage in activities that include establishing consistent, University-wide, data definitions, processes, procedures and policy; establishing clear accountability of system-defined data elements; coordinating consensus across campus; identifying, prioritizing, tracking and resolving critical data issues; raising awareness; and educating the University about data. In all of these activities, DGC will work to maximize value from New York Tech's data resources, minimize inefficiencies, and responsibly balance the trade-offs between data access, data security and data privacy.

The DGC is a standing committee sponsored by the Information Technology Services (ITS) Division. ITS will monitor the committee's activities to ensure it remains operationally functional and fulfils the stated obligations associated with data governance.

## **Meeting Schedule**

The DGC meets at least monthly; more frequently if needed. A majority of the members must be present to conduct a meeting.

## Membership

DGS is comprised of data stewards, ITS staff, IR staff and representatives from other units with University-level knowledge and responsibility for implementing/maintaining data standards in specific areas.
